THE CITY OF OMAK TO MOVE STP COMPOST BINS IN 2011



THE CITY COUNCIL OF THE CITY OF OMAK, Washington do hereby resolve that the approved Interagency Agreement for reimbursable work to relocate compost bins at the Sewage Treatment Plant, attached hereto between the **CITY OF OMAK**, a municipal corporation, and **OKANOGAN COUNTY DEPARTMENT OF PUBLIC WORKS**, a County government, with an effective date of March 1, 2006 through December 31, 2007. A new contract was signed in 2010 with no changes, and it is now hereby extended to January 1, 2011 through December 31, 2011. There are no changes to the provisions of this contract from the original agreement.

**NOW, THEREFORE, BE IT RESOLVED**, this resolution is approved and the Mayor is hereby authorized and directed to execute the same for and on behalf of the CITY; and that the City Clerk is authorized and directed to attest her signature.

**INTRODUCED** and passed this 6th day of December, 2010.



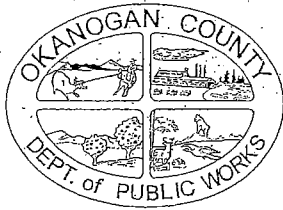
Enclosed you will find copies of the Resolution and the original agreement for 2010.

**AGREEMENT FOR REIMBURSABLE WORK**

This agreement made and entered into this 7<sup>th</sup> day of December, 2009 by and between Okanogan County Department of Public works and the City of Omak for the following work to be done:

Relocation of compost bins located at the city's sewer treatment plant

Okanogan County will provide the necessary equipment and personnel to complete the work and submit a monthly invoice for these services to the City for payment.

The city of Omak will reimburse Okanogan county Department of Public works for work performed at the rate of \$75.00 (seventy-five dollars) per hour.

It is understood that the City of Omak will hold Okanogan county Department of Public Works harmless from all claims, losses, demands, or actions for any nature whatsoever by reason of the performance of the Agreement.

This agreement shall remain in effect for the period of January 1, 2010 to December 31, 2010 and at the options of the City of Omak, with the consent of Okanogan County Department of Public works shall be renewed.
