**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OMAK,
WASHINGTON, APPROVING AN INTERLOCAL AGREEMENT BETWEEN
THE CITY OF OMAK AND FIRE DISTRICT NO. 3 FOR EQUIPMENT
MAINTENANCE SERVICES**

WHEREAS, the Revised Code of Washington, RCW 35.39 authorizes units of government within the State to enter into cooperative agreements for the provision of goods and services to each other; and

WHEREAS, Okanogan County Fire District No. 3 wishes to have the City Shop provide maintenance services on their fire trucks; and


WHEREAS, the Omak City Shop has the necessary equipment and certified personnel to perform these services; and

WHEREAS, the Fire District proposes an agreement whereby the District will pay the wages and benefits for the City personnel performing the maintenance on an hourly basis based on actual hours worked, and will pay directly for all parts used.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Omak that the Memorandum of Agreement between the City of Omak and Okanogan County Fire District No. 3, a copy of which is attached hereto as Exhibit "A", is hereby approved, and the Mayor and Clerk are authorized to execute and attest the agreement on behalf of the City.

MEMORANDUM OF AGREEMENT

CITY OF OMAK PROVIDING MAINTENANCE WORK ON
FIRE DISTRICT #3 EQUIPMENT

This Agreement, made and entered into this 8th day of December 2009, by and between the **CITY OF OMAK**, a municipal corporation of the State of Washington, hereinafter referred to as "**CITY**", and **OKANOGAN COUNTY FIRE DISTRICT #3**, an agency of Okanogan County, hereinafter referred to as the "**FIRE DISTRICT**".

WITNESSETH:

WHEREAS, the Interlocal Cooperation Act, as amended and codified in Chapter 39.34 of the Revised Code of Washington, provides for interlocal cooperation between governmental agencies; and

WHEREAS, Okanogan County Public Works Department performs maintenance work on **FIRE DISTRICT** equipment that is stored in the Omak Fire Station; and

WHEREAS, the **FIRE DISTRICT** pays Okanogan County time plus a 15% restock fee for parts; and

WHEREAS, the **CITY** maintenance department can perform the same maintenance work for **FIRE DISTRICT** equipment; and

WHEREAS, the **FIRE DISTRICT** will be billed by the **CITY** for the mechanic's time spent performing maintenance work on **FIRE DISTRICT** equipment; and

WHEREAS, parts for **FIRE DISTRICT** equipment will be charged to the **FIRE DISTRICT's** account and paid by the **FIRE DISTRICT**; and

WHEREAS, if the **CITY** mechanic is not available to make repairs on **FIRE DISTRICT** equipment, then said equipment will be taken to the County shop for repairs.

NOW, THEREFORE, IT IS AGREED BETWEEN THE PARTIES AS FOLLOWS:

1) The **FIRE DISTRICT** agrees to pay the **CITY** for actual time the mechanic has spent performing maintenance work on **FIRE DISTRICT** equipment, and parts will be charged to **FIRE DISTRICT** accounts and paid by the **FIRE DISTRICT**. If the **CITY** mechanic is not available when maintenance work needs to be performed on **FIRE DISTRICT** equipment, then said equipment will be taken to the County shop for repairs.

NOW, THEREFORE, IN WITNESS WHEREOF, the parties have executed this agreement the day and year first above written.
