MEMORANDUM OF AGREEMENT
Fire Department HVAC System

THIS AGREEMENT, made and entered into this 1st day of June 2007, by and between the CITY OF OMAK, a municipal corporation of the State of Washington, hereinafter referred to as "CITY OF OMAK" and OKANOGAN COUNTY FIRE DISTRICT #3, an agency of Okanogan County, hereinafter referred to as the "FIRE DISTRICT",

WITNESSETH:

WHEREAS, the CITY OF OMAK is installing a new HVAC system in the fire hall located at 16 North Ash Street for a cost of \$65,784.20; and

WHEREAS, the FIRE DISTRICT is desirous of sharing in 40% of the cost of said system or \$26,313.68 over a five year period at \$5,262.73 per year.

NOW, THEREFORE IT IS AGREED BETWEEN THE PARTIES AS FOLLOWS:

- 1) The Fire District agrees to pay 40% of the cost of the HVAC system over a period of five years. The payments schedule will be as follows:


